Renovation Update

- Final payment for Renovation is \$62,741.25. Due on Friday June 4, 2021
- 10% hold back from each payment
- No HST has been received from the renovation

HST and COB Deposit Update

- \$29,598.31 HST rebate pending
- Alto Mar will be paid the outstanding \$62,741.25 this week and we expect to get back the \$100,000 from the COB June 5, 2021 and then we can start rebuilding our contingency fund
