# 2. Leagues and Tournament fees

- Discussed if leagues should be limited to one league per member
- Ladies league on Tuesday/Thursday are the same type of league
- Two leagues for men/women, one during the day and a second in the evening
- No changes to leagues at this time but will be looked at in 2022. The possibility of only offering two women's leagues (not 3)
- Rule for same day bookings to be changed. Allowing members to book same day bookings after 8am
- Email to be sent out to members for court cancellations. Ask members to cancel court time by 7am the same day
- Gigasport waitlist process for court bookings should be communicated to all members
- Men's Saturday league to start at 8:00 1:00
- Thursday ladies league to start 11:30 1:30

# 4. Maintenance - Engineered walkway

- Walkway covered walkway (tent structure) from the clubhouse to the bubble. Ron to advise the architect/city that ATC is on hold for now and will be looking into other options
- \$20,000 estimate for walkway structure
- Sidewalk needs to be covered (cedars won't stop the snow). Snow will still be tracked into the bubble
- Heated industrial mats to fit the walkway (39 ft.) 2 mats approximately cost \$3,000 plus the cost of heating (120 volts for 39 feet). Heating could cost \$50-\$100 a month for hydro
- Temporary Structure Portable car garage 10 x 20 feet (\$400) build a walkway from the clubhouse to the bubble (must be 10 feet away from both structures)
- 3 ft. wide, 39 ft. walkway would use 4 ½ kilowatts of power (\$1500 a year) mats are \$2500 each to purchase
- Jesse will do more research for covered structure/walkway
- Email membership for a paid position for snow removal on the walkway leading to the bubble

- Suggested we try the temporary structure (portable car garage) this winter
- Paper towel dispensers will be put up in clubhouse
- Looking into getting 3 green compost bins and one larger recycle blue bin
- Mats for inside the clubhouse are coming on Wednesday December 1, 2021

<u>MOTION</u>: Jesse motioned to ask the junior membership for someone to shovel the snow on the walkway and a path to the front doors of the clubhouse, for \$20 an hour, seconded by Jake, all in favor.

#### 5. Other Business

- Farley to be on site next week to test the bubble
- Test to estimate how long the bubble will last so we can budget for a future replacement

# 6. Capping Waitlist

- Suggest to not add anymore members to the waitlist
- Huge risk to not add new members
- Need to have a solution for the waitlist. Still receiving inquiries, many on the list will never join ATC

#### 7. Court Booking

- Working with Jegysoft to figure out best booking time slots
- Most clubs use the 60/120 time slots
- 60/90 is not ideal (15% of clubs use this format)
- Discussed trying the 60/120 time slots in an effort to open more court time due to higher percent of singles bookings that have been observed lately
- New court times (60/120) will run for 2-4 months
- Jegysoft to be implemented in February 2022
- New court time bookings of 60 singles and 120 doubles to begin once arrangements have been made with Gigasport. Members will be notified of the exact date

Court booking singles/doubles analysis for the month of November. These numbers are the total of 90 minute slots – multiply by 1.5 for # of hours.
