Summary of 2022 Membership (10/24) follows:

Adult Temporary (Wait List/Sabbatical) - 5

Wait List additions - 7

- Refunds (\$5k) to those not joining for 2022 are placed "On Hold" until we determine who is coming back as a Temporary one-year member
- Those taking a Sabbatical for 2022 are yet to be determined
- Prorated membership fees will be done month by month
- Starting October 26, 2021 new members will receive a prorated fee
- We are not offering any Full Time memberships, only Temporary year memberships

Pro-rated Fees

- Adult \$445.72 + HST = \$503.66 (\$565.00)
- Student \$348.14 + HST = \$393.40 (\$442.96)
- Junior \$209.29 + HST = \$236.50 (\$265.55)

Court Booking

- Mixed reviews on new court times (some like it some want a 60 singles/120 doubles setup, some want it back to the way it was). We will continue the current 90 minute booking for another month or two and re-evaluate
- Discussed sending out another survey to membership about the new court times
- More people like 60 minutes for singles (past survey)
- Bookings are evenly split 50/50 for singles/doubles
- The past survey showed that 90 minutes was more popular for doubles

Leagues and Tournaments

- Next tournament is Nov 26, 27, 28 and 2022 January and March (exact dates TBD)
- Still openings in the leagues for new members
- Friday night round robins need to spread the word. Great for new members to meet others

Maintenance

- Side gate needs to be unlocked. If the rear door acts up and doesn't unlock members can use the side gate to leave
- Damar have been notified about the door locks (issues locking and unlocking)
- Altomar notified about toilet handle sticking, water running continuously
- We need indoor carpets, floors are slippery. Company exchanges carpet monthly (long runner)
- Carpets are for winter time only from October to May 1 2022 (dates to be confirmed with Company)
- AED needs to be replaced. Life span is only 10-15 years
- Prices for new AED to be looked into
- Walkway update Spoke to building inspector (City Hall), recommended an architect, will be a process to receive approval. Looking into a covered walkway/tent 10 x 20
- Walkway is covered with leaves Blower is in the shed
