# 3. Jegysoft/Membership

- Membership is doing well. Better than last year, so far 70 summer memberships
- Overall, everything is going well with Jegysoft
- Having summer guests will be opened up (Maximum of 2 guests per booking \$10 guest fee)
- We will monitor guest bookings and put a cap in place regarding a maximum number of guest bookings if the Board feels it's necessary. For the time being no CAP during the summer months
- Summer tennis begins on May 1, 2022
- Summer members can bring their own ball machines (early morning or late night). ATC ball machine is not allowed/used in the summer
- Discussed implementing ball screens to help keep the lesson balls on court 1. Jesse will look into this further. There are concerns about the extra weight of the screens on the fence. The fence is older and could get damaged
- Does Jegysoft have a questions/answers section? A forum where members can post questions and find answers. Bob will check with Jegysoft

# 4. Survey Discussion

- Lots of discussion about changing the court booking time for doubles back to 90 mins and the challenges with the 30 min gaps

## **Waitlist Update**

- The waitlist has been updated and we will have a current active waitlist of 100 which includes those who wished to remain on the waitlist and those who are temporary members this winter
- There are another 26-30 wishing to get on the waitlist
- BOD agreed to implement a policy that requires a NON-REFUNDABLE \$25 deposit to get on the waitlist
- If you are given an offer to be a member you take it otherwise you are off the waitlist. If you wish to get back on you would have to sign up for the waitlist again and pay the \$25 (injuries are not included)
- Jegysoft allows us to operate the waitlist in this format. The policy will be there when you sign up for the waitlist. Those who did pay the \$50 or \$100 to be on the waitlist will have these monies credited to their account
